AGREEMENT

THIS AGREEMENT is made on 3rd day of June 2015 at Thiruvananthapuram between the Governor of Kerala (hereinafter referred to as the "Government" which expression shall unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns) represented by the Deputy Secretary to Government, General Education (N) Department of the FIRST PART AND Sree Saraswathy Vidyanikethan, Mulayankavu P.O., Kulukkallur, Palakad District (hereinafter referred to as the Educational Agency which expression shall unless it be repugnant to the context or meaning thereof, be deemed to mean and include its successors and assigns) represented by Ramesh P.P., Secretary. WHEREAS the Educational Agency has established a School by name Sree Saraswathy Vidyanikethan, Mulayankavu P.O., Kulukkallur, Palakkad District in the year 2001.

AND WHEREAS the School has requested NOC from the Government for getting CBSE affiliation.

AND WHEREAS the Educational Agency hereby agrees that it would conduct the school only in accordance with the guidelines prescribed by Government in G.O.(MS)No.202/11/G.Edn. dated 07.10.2011 and such conditions as may be prescribed by the Government of Kerala from time to time.

AND WHEREAS the Government have decided to issue sanction to the Educational Agency to conduct CBSE syllabus in the school vide G.O.(MS)No.145/2015/GEdn dated...28.12.2015... approved by the Secretary to Government, General Education Department the details of which are annexed hereto which shall form part of this Agreement as if incorporated herein.

AND WHEREAS in consideration of the aforesaid decision of the Government, the Educational Agency specifically agrees to run the school in accordance with the terms and conditions hereinafter set below:-

1. The Educational Agency agrees to submit the documents to prove that the school has adequate infrastructural facilities, human and physical to conduct the school as per the approved syllabus as required by the Government.
2. The Educational Agency agrees to abide by the condition that the medium of instruction of the school shall be English and Malayalam shall be compulsorily taught as a paper with a prescribed text book and proper academic evaluation as instructed by State Government from time to time.
3. The Educational Agency agrees that the rate of tuition and other fees charged shall commensurate with the facilities provided and a


yearly return of the fee charged (all fees) shall be filed before the District Educational Officer concerned and in the school website.


4. The Educational Agency agrees to appoint only qualified and eligible staff and agrees to pay the salary and allowances and other benefit to the employees of the school. Employees in the CBSE school shall be offered the same pay scales as in Government schools for equivalent categories. The pay shall start at the minimum of the scale and employees shall be eligible for DA and increments as is allowed in Government schools from time to time.
5. The Educational Agency agrees to follow the pupil-teacher ratio of 30:1 in all classes and to enroll the teacher thus required in CPF Schemes.
6. The Educational Agency agrees that the admission to the school shall be open to all without any discrimination on the ground of religion, caste or race, place of birth of any of them and that the school shall strictly comply with RTE Act and Rules and shall provide admission to students belonging to category to be notified by Government to 25% of seats. The fees payable by such students shall be fixed by Government from time to time.
7. The Educational Agency agrees to enable the Government and its representatives to inspect, verify and monitor the school and its records at any time the Government so decides and the school shall furnish all information as may be required for by the Government.
8. In the event of breach of any of the conditions mentioned above by the Educational Agency, the school run by the Agency will be closed down with effect from the beginning of the next academic year.

The Educational Agency agrees to obtain and submit before the Government the duly attested copy of the letter of affiliation from the respective Boards within 15 days of receipt of the same.



10. In the event of breach of any of the condition mentioned above by the Educational Agency, the Government is authorized to adjudicate the question of compensation which the Educational Agency is liable to pay to the Government, if any, and upon such adjudication the Educational Agency shall pay to Government the amount so fixed, failing which the amount of compensation adjudicated shall be recoverable under the provision of the Kerala Revenue Recovery Act, 1968, as if they were public revenue due on land.
11. In the event of the breach of any of the conditions mentioned above by the Educational Agency, the Government shall also be entitled to withdraw the NOC/Sanction without formal notice to the Educational Agency.
